Abstract: the article discusses and analyzes the organizational structure regional center for social services for elderly and disabled people.

Keywords: social protection, organizational structure.

Social protection is a system of measures aimed at respecting human rights and meeting human social needs.

Types of social protection.

Social protection is provided at the state level and in private.

The state forms of social protection include:

1) affordable health and education;

2) pension provision;

3) social service and social service delivery system;

4) exemption;

5) social support measures.

Non-state forms of social protection are:

1) charity;

2) voluntary social insurance;

3) private health systems, etc [3].

Social protection system in the Russian Federation.

The social protection system includes budgetary and extra-budgetary funds at the Federal, regional and local levels.

State extra-budgetary funds providing social protection in the Russian Federation:

1) pension Fund of the Russian Federation;

2) social insurance Fund of the Russian Federation;

3) compulsory health insurance Fund [5].

Thus, social protection is a multi-level system of economic, legal, organizational, medical and social, pedagogical, psychological and other measures aimed at the realization of individual rights and freedoms in the field of social security, guaranteeing not only survival, but also a sufficient level and quality of life.

In the Stavropol region, a system of social services for citizens has been formed that allows them to provide them with state social guarantees established by federal legislation and the legislation of the Stavropol region in the form of a wide range of social services.

Regional Center for Social Services (hereinafter referred to as the Center) is one of such social service centers, which provides various types of social services to elderly citizens, low-income citizens, and citizens with disabilities [7].

If we analyze the system of social protection in the city of Stavropol, we can note the following. The institutions of the social security system of the city of Stavropol that deal with issues of social services for the population in the Stavropol region include:

- 1) the Ministry of Labor and Social Protection of the population of the Stavropol region;
- management of labor and social protection of the population of the city of Stavropol;
- 3) center for social services.

These institutions operate on the territory of the city of Stavropol, but similar institutions exist and work throughout the territory of the Stavropol region and the role of the above and other similar institutions of the social protection system in resolving issues of social services for the population in the city and the Stavropol region is:

 in carrying out on the territory of the city and territory of the state policy in the social and labor sphere;

 in providing social support to certain categories of citizens and social services in accordance with the legislation of the Russian Federation and the legislation of the Stavropol region;

 in the development of a system of social partnership and contractual regulation of labor relations in the city and territory;

- to participate in the implementation of the main directions and priorities of state policy in the field of demography, labor relations, the development of labor resources, labor migration, alternative civil service, raising the standard of living and incomes of the population;

 in the implementation of state management of labor protection in the city and territory;

- to participate in determining priorities in implementing social policies regarding persons with disabilities in order to ensure equal opportunities for them and social integration in society, etc (Table. 1).

The organizational structure of Regional Center for Social begins with the activities of the Ministry of Labor and Social Protection of the Russian Federation, then extends its activities to the Ministry of Labor and Social Protection of the Stavropol Territory. After that, Regional Center for Social Services for Elderly and Disabled Citizens describes its organizational structure [7].
